



# SPRING CONTEST RULES

## CONTEST CLOSES MAY 15, 2019

### HOW TO PLAY

**1. TO PLAY:** Commencing on or about March 15, 2019, customers at participating Garden Centre locations in Canada may select **specially marked Florissa Brand packages** of:

**Bonus Pack Gladiolus Mix, Bonus Pack Oriental Lily Stargazer, Bonus Pack Dahlia Dinnerplate Mix, or Bonus Pack Peony Mix**, to purchase while supplies last. Each specially marked package will have a sticker in the upper flap with a contest code. To claim your prize, refer to instructions which follow, but to be eligible, all contest Package Codes must be confirmed on-line at [www.Florissa.com/Spring2019contest](http://www.Florissa.com/Spring2019contest) by May 15, 2019 at 11:59:59 p.m. PT. Potentially winning Package Codes must be submitted complete. The Contest Sponsor (defined below) reserves the right in its sole discretion to reject any potentially winning codes if the information is not complete when submitted.

**2. NO PURCHASE NECESSARY TO PLAY:** To obtain a FREE Contest code and/or a copy of the official rules, please send a request in writing to: "Florissa Spring 2019 Contest" Code & Rules, 22264 Hwy #10, Langley, BC, V2Y 2K6. All requests for a FREE Code must be postmarked by April 30, 2019 and received by May 5, 2019. Limit of one FREE Code request per envelope with sufficient postage, while supplies last. No mechanical reproductions of requests permitted. Open to residents of Canada, excluding Quebec. All FREE Code requests must include a postage-paid, self-addressed return envelope.

### CONTEST PACKAGE CODES

**3.** A minimum of 4,500 Packages with Codes will be produced for this contest. Packages will be available for distribution until April 30, 2019 or while supplies last, whichever occurs first. It is anticipated, based on participating garden centres that estimated distribution of these Packages with Codes will be distributed within three (3) regions (each, a "Region"), as follows:

1) British Columbia - 2,500

2) Alberta, Saskatchewan, Manitoba - 700

3) Ontario - 1,300

### PRIZES AVAILABLE ACROSS CANADA

**4.** The following prizes are available to be won across at participating garden centres across Canada, excluding Quebec.

**A) One (1) \$1000 Gift Card for Goods and Services at a Participating Garden Centre**

**B) Ten (10) \$100 Gift Cards for Goods and Services at a participating Garden Centre**

All retail values do not include applicable goods and services tax, provincial/territorial sales and use taxes. Winners are not required to pay such taxes upon receipt of the applicable Prize. All other taxes on Prizes other than taxes specifically referred to in these official rules are the responsibility of the winners. All characteristics and features of the Prizes, except as otherwise explicitly stated above, will be determined by the Contest Sponsor in its sole and absolute discretion.

### PRIZE DISTRIBUTION

**5.** Estimated distribution of a "Winning" Package Code for a Gift Card is random across Participating Regions of Canada, excluding Quebec.

**6.** All Prizes will be awarded to winners by the Contest Sponsor after **May 15, 2019** and before **June 15, 2019**.

### ODDS OF WINNING

**7.** A total of eleven (11) Gift Cards are available to be won in Canada, excluding Quebec. The overall approximate odds are 1 in 4,500. NOTE: The denominator used to calculate the odds provided above is an estimate of the maximum number of applicable Package codes that might be produced for this contest, which is equal to the sum of the applicable minimum number of Package Codes (see Rule 3) and a 10% maximum possible Package Code overproduction variance.

### GENERAL RULES

**8.** Contest commences on or about March 10, 2019 and Packages with Codes will be available at each participating Garden Centre until April 30, 2019 or while supplies last, whichever occurs first. To be eligible, contest Package Codes must be submitted on-line at [www.Florissa.com/Spring2019contest](http://www.Florissa.com/Spring2019contest) by May 15, 2019 at 11:59:59 p.m. PT.

**9.** Liability for irregular, illegible or blank Contest Package codes is limited to replacement with another Code, while supplies last. If, due to a production, printing error or any other type of error, there are more Prize claims than Prizes available at the applicable pricing level, Contest Sponsor reserves the right to award any remaining Prizes for that level through a random draw from among all eligible Prize claims at that level. It is extremely rare to receive an irregular, illegible or blank Package Code. If this should occur, return the irregular, illegible or blank Contest Package Code (see Rule 2 for address) and it will be replaced, within the contest timelines with a new Contest Package Code, while supplies last.

**10.** Contest Package Codes obtained through unauthorized sources or which are incomplete, mutilated, altered, reproduced, forged, counterfeited or irregular in any way, are automatically void. No Contest Package Codes copied, duplicated or reproduced of any type will be eligible for the contest. Contest Sponsor is not responsible for any lost Package Codes. Package Codes are the property and intellectual property of Contest Sponsor, and may not be used for any other promotional, commercial or other purposes without the authorization of Contest Sponsor.

**11.** Each Prize claimant must be a resident of Canada. To be eligible to claim a Prize, Prize claimants must have reached the legal age of majority in their province/territory of residence or in the event a person under the legal age of majority receives an eligible "Winning" Package Code, they are permitted to transfer such Package Code to their parent or legal guardian, who will then be the eligible entrant.

**12.** Employees, representatives or agents of, or those domiciled with an employee, representative or agent of, Van Noort Bulb Co. Ltd. (the "Contest Sponsor") are not eligible to participate nor win a Prize in this Contest. The Contest is not open and void where prohibited by law.

This section does not limit any other consent(s) that an individual may provide to the Contest Sponsor or others in relation to the collection, use and/or disclosure of their personal information.

**16.** By claiming a Prize, Prize claimants' consent to the use of their name and/or photograph, and/or place of residence, without further compensation, in any publicity carried out by the Contest Sponsor in perpetuity and in any media worldwide.

**17.** The Contest Sponsor is not responsible for lost, late, illegible, incomplete, mutilated, misdirected or postage-due official rule requests, FREE Package Code requests, or Prize claims. Contest Sponsor is not responsible for lost, stolen or damaged Garden Centre gift card prizes.

**18.** By accepting a Prize, winners release the Contest Sponsor, Van Noort Bulb Co. Ltd. and their affiliated and related companies, Garden Centre Prize suppliers, Garden Centre Prize sponsors, and their respective officers, directors, employees and agents, including, without limitation, their advertising and promotional ("Releasees"), from any and all liability, loss or damage incurred with respect to the awarding, receipt, possession and/or use or misuse of any Prize and acknowledge that the Releasees have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee, express or implied in fact or in law, including but not limited to its quality, mechanical condition or fitness for a particular purpose.

**20.** The Contest Sponsor reserves the right to suspend, cancel or modify the contest at any time, if it determines that for any reason the contest cannot be run as originally planned or for any other occurrence compromising the fairness or integrity of the contest.

**22.** Where applicable, the Contest Sponsor reserves the right to publicly award Prizes at the Garden Centre where the Package Code was originally received.

### HOW TO CLAIM A PRIZE

**23.** If you are eligible to win a prize COMPLETE THE PRIZE CLAIM FORM. Upon receipt of your completed Prize Claim Form, the Contest Sponsor will verify your prize claim and will then contact the potential winner by telephone, to administer a time-limited Skill-Testing Question. In order to be declared a winner, you must have correctly answered a Skill-Testing Question.

**a. Mail-in Option:** To exercise the mail-in option, COMPLETE PRIZE CLAIM FORM, including the Skill-Testing Question. In order to be declared a winner, you must have correctly answered a Skill-Testing Question. PLEASE NOTE: Package Codes that do not include the entire 12-digit Code will be considered incomplete and will be disqualified. Upon receipt of your completed Prize Claim Form, the Contest Sponsor will verify your prize claim. In the event more than one claim is received for prize, only the first such claim that is received by the Contest Sponsor in accordance with these official rules (as determined by the Contest Sponsor in its sole and absolute discretion) will be deemed valid.

**b. On-line/Email Option:** To exercise the On-line option, COMPLETE the On-line Prize Claim form, at [www.Florissa.com/Spring2019contest](http://www.Florissa.com/Spring2019contest), including the Skill-Testing Question, on or before May 15, 2019 and submit a digital photo of the winning Package Colour front and Winning Package Code to [mail@florissa.com](mailto:mail@florissa.com). All emails submitted must note in the subject line: "Florissa Spring 2019 Contest" and must have your complete contact information including full name, address and phone number. Maximum digital photo size 3 megabytes. Any images that are not legible will be disqualified. The Contest Sponsor holds the right to request you to mail-in the originals package and code. Upon receipt of your completed Prize Claim Form, the Contest Sponsor will verify your prize claim. In the event more than one claim is received for a winning Package Code, only the first such claim that is received by the Contest Sponsor in accordance with these official rules (as determined by the Contest Sponsor in its sole and absolute discretion) will be deemed valid.

Participating Garden Centre Owners, Operators and Staff are not allowed to submit Package Codes on behalf of potential winners. The Contest Sponsor shall have the right to request that the potential winner present government-issued photo identification to verify the potential winner's identity and eligibility.

**24.** For eligible prize winners we STRONGLY RECOMMEND sending all Prize claim materials by REGISTERED MAIL and keep a copy of the Package Code and Prize Claim Form(s) for your records, as we will not be responsible for lost or delayed Prize claims.

**25.** Prize claims must be postmarked on, or before, **May 15, 2019** and received at the above-noted address no later than May 20, 2019 otherwise such claim shall be null and void and ineligible for a Prize. The Contest Sponsor will notify the confirmed winners by telephone and arrange prize gift card distribution in conjunction with the local participating Garden Centre by **June 15, 2019**. If any Prize notification or any Prize is returned as undeliverable, such Prize will be forfeited.
